All institutions whose DD's/cheques have expired should send fresh DDs/cheques and/ or deposit the same by way of RTGS/NEFT/online mode, but deposit of such amount will not lead to accrual of any right to any such institution, if otherwise the application is defective on any count.

All Centers of Legal Education /proposed CLE's who may be depositing money in the account of BCI through RTGS/NEFT/online transfer as mentioned above should email all such details of institution name, head under which payment is being made and the relevant period for which the payment is being made and other relevant details to accdleonline@gmail.com,
