

The office was directed to send a reminder letter to such Institutions. The office is to send reminder to ask for compliance report from all the Law Universities/colleges/schools before the next academic session. In case of failure of Institutions, necessary action would be taken. A Sub-Committee consisting of Mr. Satish A. Deshmukh, Mr. Rajinder Singh Rana, Mr. T.S. Ajith, Mr. Bhoje Gowda S.L., Mr. Bhojchander Thakur would monitor the same; and Hon'ble Mr. Manan Kumar Mishra will be the Special Invitee in that Committee.

Moreover the Bar Council of India has sent a circular No. BCI:D:211:2013(LE/Circular No.3) dated 21st March, 2013 as per the Resolution of the Bar Council of India to the all the law colleges and Universities to subscribe AIR products with 58% discount to the libraries of law colleges and Universities imparting legal education on the occasion of Golden Jubilee year of the Bar Council of India. But so far most of the law colleges have not complied the above said circular.

Therefore you are once again requested to comply the above said Resolution and the circular and inform the Council on or before 31st March, 2014. After receiving your compliance report the matter will be placed before the above said Committee. I am also enclosing a copy of the above said circular for your consideration. The Bar Council of India at its meeting held on 24th and 25th November, 2013 has considered the above mentioned subject and resolved as follows:

Resolution No. 240/2013

The minutes of the Legal Education Committee, Bar Council of India held on 17th November, 2013 was considered and is hereby confirmed.

It was pointed out by Hon'ble Members that in the meeting of Legal Education Committee, it is always found that most of the Institutions the requirement of sufficient library/books/other material etc., are not being fulfilled and the Legal Education Rules 2008 and other resolutions of the Council are not complied with. The conditions of most of Institutions imparting Legal Education is almost same. Most of the Institutions have not even sent their compliance report with regard to the resolution of the Council which was taken vide Resolution No. 16 of 2013 dated 2nd February, 2013 and Resolution No. 238 of 2013 dated 29.9.2013 with regard to Database, C.D. and other study materials (with regard to Law & Legal Education). This is to be included in the L.E. Rules, 2008 as a prescribed course/material for the institution imparting Legal Education.
