The 29th All-India Inter-University Moot Court Competition for Law students sponsored by the Bar Council of India Trust will be held at "**Mody Institute of Technology & Science, (Deemed University) Faculty of Law, Lakshmangarh, Distt-Sikar (Rajasthan)**". Please note that only the Universities are eligible to sponsor teams consisting of **Three Students (two mooters and one researcher)**. Law colleges outside the Universities must get in touch with the Universities to which they are affiliated and get their nominations sent through Deans/Registrars. **The nominations received from the law colleges directly (instead of through the University) will not be entertained.** Only law students studying the LL.B courses are eligible to contest.

However, if for any reason, they are unable to meet the travel costs, the Bar Council of India Trust will provide second-class fare to the participating students (both ways subject to production of photocopy of travel tickets). Further, the entire boarding and lodging expenses of the students will be met by the Host University. The rules and regulations in respect of the competition are as in the past.

The Bar Council of India Trust will award National Merit Certificates and other Prizes. Scholarships of Rs.1000/- per month for a period of one year will be provided to the First Rank holder in each round of the competition. Outstanding briefs presented during the contest may be considered for publication in the Indian Bar Review, the Journal of the Bar Council of India Trust.

I am writing this to formally invite your University for this year's competition. Those universities who have more than one Law College may organize a selection contest in order to select the representative team of two law students. It is requested that this communication may be given wide publicity and the names of the participating students with their mailing addresses and contact number representing your University for the competition be communicated to Host University on the above university address as well as on the Email: mootcourt.folmits@mitsuniversity.ac.in and confirming the same to the undersigned through email on trustbci@gmail.com also on or before **30th July, 2013**.

I request you to give early consideration to this important academic programme and send your entries well before the last date mentioned by the Universities concerned, so that they may send the Moot Problems and other details to the concerned students for their study and preparation well in time.
