As per the decision of the Council Meeting held on 29th December, 2013, vacancies for various posts were advertised in the Indian Express on 15th January, 2014. In reference to the advertisement, applications from the candidates have been received as per details given below: -

1. One application of Ms. Swati Sehgal for the post of Assistant Grade – I has been received without Demand draft.
 2. One application of Mr. Praveen Kumar Pandey for the post of Daftary has been received without Demand draft.
 3. One application of Ms. Sunita for the post of Legal Assistant after cut off date (i.e. 21st January, 2014) received on 23rd January, 2014. Although, demand draft dated is of 20.01.2014.
- *All these four applicants would sit in the test at their own risk.
The final decision would be taken by the Council, whether to entertain their applications or not !

4. Council has decided to modify its earlier Resolution and has resolved not to make any appointment on the post of Assistant Medical Officer post (code No. 01) so there shall be no test for this post. The Demand Drafts sent by these candidates shall be returned to the applicants of this post after 3rd February, 2014.

For the post of Peon post code No. 07, 12, for the Cook post code No. 08 selection will be made on the basis on the interview only to be held on 3rd February 2014.

Similarly, the Council has decided to defer the decision for appointment of the Drivers for the time being. No appointment shall be made on this post. The Demand Draft shall be returned after 3rd February, 2014.

5. For other post i.e. Assistant Public Relation Officer post code No. 2 and 10, Legal Assistant post code No. 3, Assistant Grade-I post code No. 4 and 11, and Daftary post code No. 5 there will be written test to be held on 31st January, 2014 and candidates will be shortlisted on the basis of the result of written test and interview of the shortlisted candidates will be held on 3rd February, 2014.

Note:- The written test will contain 85 marks while interview/oral test will be of 15 marks. Written test would be held in following subject: -
