Sir(s),

The General House of the Council at its meeting held on 17th June, 2014 considered under Item No. 186/2014 regarding extension of date of holding All India Bar Examination-VII and passed the following decision: -

"Council considered the request received from Gujarat Bar Council seeking extension of date of exam on the ground that some of the University of Gujarat State had declared the result of 3 year and 5 year LL.B. Course, but the work of distribution of mark sheet has not started till date as well as some of the Universities of Gujarat State has not declared the result of 3 year and 5 year LL.B. Course. Various letters have also been received from M/s ITES Horizon Pvt. Ltd. requesting to extend the date of examination on the various grounds. Another request of extension of date is received from the State Bar Council of Andhra Pradesh stating therein that enrolment process of advocates has been stopped because of bifurcation of the State of Andhra Pradesh and Council has decided in today's meeting under Item No.179/2014 that Bar Council of Andhra Pradesh can continue with the enrolment of advocates. The enrolment process has been delayed and many persons are waiting to be enrolled in the State Bar Council.

The Letter has also been received from Madhya Pradesh State Bar Councils stating therein that on 27.07.2014 the judicial examination is also scheduled to be held in the State of Madhya Pradesh. Another Letter No.SBC/MP/Enrolment/4059/2014 dated 16.06.2014 has also been received from the Officiating Secretary of the Bar Council of Madhya Pradesh requesting to extend the date of examination from 27.07.2014 because the process of enrolment was stopped due to the election of the Bar Council.

Looking into the difficulties faced by the candidates and request received from various Bar Councils, Council is of the view that this exam date is to be extended at least for one month. In the same way, the last date of receipt of application should be increased. M/s ITES Horizon Pvt. Ltd. is requested to give the new schedule to hold the exam. Council Resolves accordingly."

You are kindly requested to fix the suitable date of examination, so that the date fixed for the AIBE-VII will not clash with any other exam especially Judicial Exams."

The new schedule for registration, cut off date for challan, last date for completion of online form will be uploaded on the website of the Bar Council of India i.e. www.barcouncilofindia.org shortly.
